

REGULAR MEETING

July 8, 2025

The Rosedale Town Council held their regularly scheduled meeting on Tuesday, July 8, 2025 at 7:00 p.m. at the Rosedale Town Hall. Carol Brown, Barbara Leitgabel, Cody Mason and Diane Balder were present. Brown made the motion to approve the minutes from the June 10 meeting, seconded by Leitgabel. All in favor.

OLD BUSINESS:

TOWN WEBSITE: Has been launched. The town will be posting events, business information and more. We will be uploading ordinances and adding more content. The Town has also created a Youtube channel to live stream our meetings from to meet the new state requirement for transparency.

TOWN HALL DOOR: Still waiting on the door.

COMMUNITY CROSSINGS 2025: Updating PAMP.

WEB-SITE ADVERTISING - The Town Attorney has said that we can sell advertising on the web-site. We cannot limit it to our area only. The Town will do more research on this.

NEW BUSINESS:

NEW POSITION: The town is still seeking a part-time Street Superintendent. Our part-time employee, Jake Roderick will be staying on through the school year. He is doing a work-based program.

ROSEDALE FOREVER FUND: Brown, Leitgabel and Montgomery have been looking at a new playset for 2-5 year olds for the park. The set would be paid for by the Rosedale Forever Fund Money from the Parke County Community Foundation. The new equipment will cost \$9949.00. Brown made the motion to approve, seconded by Balder. All in favor. We will need volunteers to help install. The Council also discussed pouring a new sidewalk and re-pouring part of the basketball court. Brad Thompson quoted the town \$2310 for the basketball court and \$6810 for new sidewalk at the park. Mason has contacted Thompson's about the price of the concrete for the sidewalks. Leitgabel made the motion to approve the basketball court, seconded by Balder. All in favor.

DEPARTMENT REPORTS:

WATER/SEWER:

Penalties - 89, Tags Hung - 7, Shut-off - 1

Three leaks have been repaired. Discussion took place about the continuous leak on the west hill. Council members agreed that it needs to be fixed. McClintock will ask Gary for a quote. Discolored water has been an issue. Water Operator Nuckols thinks it may be due to the using a different well. McClintock worked with Auterson on the Lift Station due to a pump being down.

STREET:

The town discussed the recovery of the old tractor. Brown made the motion to approve up to \$500 to purchase a new starter for the old town tractor that was recovered after it was stolen last September. Seconded by Balder. All in favor. Balder asked about placing the no parking signs. McClintock has called in locates and they have not been located. Patching needs done.

Bratcher says that the Town Attorney will need to get involved on several properties.

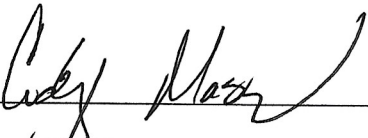
CLERK-TREASURER: Montgomery was on vacation.
